SUBJECT: Summer Internships

It's my pleasure to invite you to consider participating in the University of Georgia's 2011 Summer Intern Program for Risk Management and Insurance students. In addition to greatly assisting in the education of this generation of students, the potential advantages to you include: (1) high-quality help at times when regular employees are on vacation and (2) a close look at prospective employees who plan to enter your industry directly from college. Last year, our students who received practical experience through an internship considered it one of their most worthwhile endeavors to date. Their employers were equally enthusiastic!

Eligible students include juniors or seniors who have completed at least one insurance course. They must enroll in summer school, complete a written project, and have their supervisor provide us with a confidential evaluation. Compensation of at least \$8.00/hour is recommended, but we recognize that a lesser base compensation plus incentives may be appropriate in some sales organizations. If your location is other than the student's home area, housing allowances are both permitted and encouraged.

Regarding timing, our spring semester ends on May 10 and Fall classes begin on August 15, so most of our students should be available to work from mid-May through early August.

Interested employers may either (1) conduct formal campus interviews or (2) have interested students send them resumes. For those who wish to conduct on-campus interviews, please contact our Career Services Center as described on the enclosed form. For those who wish to use any other approach (on-site interviews, phone interviews, etc.), we will provide information about your internship to our students, and interested students will send you a resume. You can then proceed however you wish in selecting your intern(s) from this pool. We'll begin providing information to students about internship opportunities early in the month of February, so the sooner you indicate your interest, the better your chance of securing just the right student for your needs.
