BIOGRAPHY

James M. Carson is the Daniel P. Amos Distinguished Professor of Insurance in the Terry College of Business at the University of Georgia. Professor Carson serves as the Head of the Insurance, Legal Studies, & Real Estate Department, and also as the Director of the C. Herman Terry Risk Management & Insurance (RMI) Program. He teaches various RMI courses at the undergraduate, masters, and doctoral levels, including a First-Year Odyssey course entitled, "Who Is Warren Buffett?" Prior to joining the faculty at UGA, he served as the Midyette Eminent Scholar in the RMI Program at Florida State University (2001-2011) and as the Katie Research Professor at Illinois State University (1993-2001). Dr. Carson received his bachelor's and master's degrees in Finance from the University of Nebraska. Since earning his Ph.D. in Risk & Insurance from the University of Georgia, he has received several teaching and research awards. In 1998 he completed the Lloyd's of London / Katie Executive Education Program through Lincoln College at Oxford University.

Professor Carson is a Past-President (2004-2005) of the American Risk and Insurance Association, the world's premier academic risk and insurance organization. He also is a Past-President of the Western Risk and Insurance Association, a member of the Risk Theory Society, and a member of the Southern Risk and Insurance Association. He served as Interim Editor for the *Journal of Insurance Regulation* (2009-2010), as Editor for the *Journal of Insurance Regulation* (2009-2010), as Editor for the *Journal of Insurance Regulation* (2001-2005), and he serves as a referee for various publications and on several editorial boards, including *Risk Management and Insurance Review, Journal of Financial Service Professionals*, and *Journal of Risk Education*. He holds the CPCU, CLU, and ARM professional designations.

Professor Carson's research is focused on (1) the economics of risk and insurance, (2) market discipline, (3) insurer operations, pricing, and solvency, (4) regulatory and ethical issues, and (5) financial planning. He is co-author of a collection of essays on Risk & Insurance principles based principally on Buffett & Munger's writing and speaking dating back to the 1960s, and is co-author of the book entitled, *Life Insurance Analysis*. He also is co-author of the forthcoming (15th) edition of *Principles of Risk Management and Insurance (Rejda, McNamara, Carson, Volkman-Wise)*.

Dr. Carson and his work have been featured in *Fortune*, the *Wall Street Journal*, and other prominent outlets, and his publications have appeared in various scholarly and professional journals including *Journal of Risk and Insurance*, *Insurance: Mathematics and Economics, Journal of Banking and Finance, North American Actuarial Journal, Risk Management and Insurance Review, Journal of Insurance Regulation, Journal of Business Ethics, Journal of Insurance Issues, Scandinavian Actuarial Journal, Journal of Actuarial Practice, Financial Review, and other academic and professional journals. Dr. Carson has worked for Georgia-Pacific Corp and Old Line Life, and he has served as a consultant to various companies. Professor Carson has provided expert testimony in litigation on various issues relating to property-casualty insurance and life insurance, including issues such as damages calculations, insurance contract interpretation, life settlements, cost of insurance charges, demutualization, and life insurance valuation. He is a core member of the Crisis Communication Coalition with UGA's Grady College at UGA, as well as a member of the Advisory Council of the Griffith Insurance Education Foundation.*

Since 1987, Dr. Carson has taught 17 different courses at various universities including the University of Nebraska, Illinois State University, Florida State University, and the University of Georgia. In addition, he has instructed professionals in courses for the Risk and Insurance Management Society (RIMS), executives through the Lloyd's of London Study Tour (with the Katie School of Insurance), and professionals at various insurance organizations through FSU's premier online master's RMI program, as well as an online program through a partnership among UGA, The Institutes, and the Council of Insurance Agents and Brokers.

Professor Carson has given presentations before various groups including academics, regulators, and industry professionals, with many of these discussions on the topics of insurer operations and financial strength/solvency, insurance products/performance, and the U.S. insurance market. Professor Carson has spoken at sessions on Capitol Hill from 2009-2017 for the House Financial Services Committee and staff. He also has lectured and served as moderator for the National Council of Insurance Legislators (NCOIL), and he served as an academic moderator for meetings of the International Insurance Society (IIS).
