The Terry College has long emphasized the importance of preparing students for the global marketplace by offering opportunities to study, work, and volunteer internationally. These experiences enhance cultural understanding and can be transformative, providing students with meaningful learning opportunities in an internationally attuned curriculum. **International Business Education** at the Terry College is in high demand and offers a host of opportunities for students to gain that much-needed global knowledge.

INTERNATIONAL BUSINESS CO-MAJOR

International Business is a popular comajor offered to Terry undergraduates. Students pair IB with one of the primary BBA majors. More than 290 undergraduates were enrolled in the IB co-major in 2020-21. That same year, 128 students graduated from Terry with the IB comajor.

STUDY ABROAD AND STUDENT EXCHANGE

Terry College students account for almost one-third of all UGA study abroad. Terry offers a variety of study abroad programs throughout the year to maximize their ability to participate in an international education experience. Faculty-led study abroad programs allow students to take a course taught by a Terry faculty member while abroad. Foreign exchange programs allow students to live and study for a semester abroad independently.

PASSPORT TERRY SCHOLARSHIPS

The Terry College awards need- and merit-based scholarships for business majors to participate in approved international business programs. The scholarship awards range from \$500 to \$5,000.

INTERNATIONAL VISITING **SCHOLAR PROGRAM**

The program offers opportunities for prominent scholars from non-U.S. institutions to collaborate and engage with faculty and students at the Terry College of Business. The program is intended to enhance academic research and allows scholars to share their expertise through teaching and speaking opportunities. Appointments span up to two weeks, and the program supports one visiting scholar each academic year.
